

SUPPLEMENTAL
PUBLICATION ORDER

WHEREAS the Court having read and considered the proposed Supplemental Notice of Wage & Hour Class Action Lawsuit and the materials submitted in connection with Motion Seq. No. 16 and the supplemental briefs associated with the same; and

WHEREAS the Court finding that there exist substantial and sufficient grounds for entering this Order;

IT IS HEREBY ORDERED THAT:

1. On or before 10 days after entry of this Order, Defendants shall furnish Class Counsel with a supplemental list of any known service workers – that were not previously disclosed – that performed work at Defendants’ catered events at the facility commonly known as Renaissance Westchester Hotel, along with their full names, email addresses, and contact

information, including the names of any individuals that obtained employment through Interstate, Planit New York LLC, or any staffing agency since January 2010.

2. On or before 30 days after Defendants supply Class Counsel with the list set forth in Paragraph 1, Class Counsel shall provide Supplemental Physical Notice (**Exhibit A**) – in English and in Spanish – via First Class Mail to all Class Members identified by Defendants or whose contact information has been obtained by Class Counsel, including information obtained by Non-parties.

3. Within 45 days after entry of this Order, Plaintiffs shall publish the Court-approved Supplemental Publication Notice (**Exhibit B**) in the following manner:

- a. In a newspaper of general circulation within Westchester County once a week for a period of four consecutive weeks – in English and in Spanish;
and
- b. In a newspaper of general circulation within Queens County, New York, once a week for a period of four consecutive weeks – in English and in Spanish.
- c. On Leeds Brown Law, P.C.'s website – in English and in Spanish.

4. The Court approves the form of the Supplemental Physical Notice and Supplemental Publication Notice of Class Action and finds that the publication of such Supplemental Physical Notice and Supplemental Publication Notice will constitute the best notice practicable under the circumstances to members of the Class pursuant to CPLR § 907(2).
